This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. Avoid mist or vapour formation. As a minimum, wear overalls, goggles and gloves.
