Ingestion	A moderate hazard exists from inhalation of spray and care should be taken to avoid inhalation of spray mists. Possible symptoms of exposure include: nausea, vomiting and gastrointestinal discomfort and diarrhoea. If aspirated into the lung, e.g. from vomiting, the presence of surfactant may result in chemical pneumonitis or other lung damage.
Skin	Prolonged contact with the concentrate can cause defatting of the skin and may result in dermatitis. May irritate the skin.
Eye	The concentrate will cause irritation of the eyes. Possible symptoms include redness, swelling, tearing and pain.
Chronic Effects	Based on available data, repeated exposures are not anticipated to cause additional significant adverse effects.

13. DISPOSAL CONSIDERATIONS

Product Disposal On site disposal of the concentrated product is not acceptable. Ideally, the product should be used for its intended purpose. If there is a need to dispose of the product, approach local authorities who hold periodic collections of unwanted chemicals (ChemClear®).

Container Disposal Do not use this container for any other purpose.
Triple rinse containers, add rinsate to the spray tank, then offer the container for recycling/reconditioning, or puncture top, sides and bottom and dispose of in landfill in accordance with local regulations.
drumMUSTER is the national program for the collection and recycling of empty, cleaned, non returnable crop production and on-farm animal health chemical containers. If the label on your container carries the drumMuster symbol, triple rinse the container, ring your local Council, and offer the container for collection in the program.
If on-site container disposal is necessary, triple rinse empty container with water, add rinsate to the spray tank. Puncture top, sides and bottom, crush and bury in an approved landfill or bury with at least 500 mm of soil cover away from pasture and crop areas, water supplies and houses.
