Section 4 - First Aid Measures

General Information: You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

Inhalation: If dusts have been inhaled, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists for more than about 30 minutes, seek medical advice

Skin Contact: Wash affected areas with water until chemical is removed. Remove all contaminated clothing and launder before re-use. If in doubt obtain medical advice.

Eye Contact: Immediately irrigate with copious amounts of lukewarm, gently flowing water for 15 - 20 minutes or until the product is removed or irritation has ceased, while holding the eyelid(s) open. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

Ingestion: Give a glass of water if affected person able to drink. Do not induce vomiting unless instructed to do so by medical advice. Notes to Doctor: Treat symptomatically.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: Not combustible, but contains strong oxidising agent - potassium nitrate @ approx 50%. Potassium nitrate will support combustion of other materials. Fight fire from a protected position and use water spray to reduce product temperature. Decomposition may give rise to toxic and noxious fumes including nitrogen oxide. Wear self-contained breathing apparatus (SCBA) Extinguishing Media: Not Combustible. Use extinguishing media suited to burning materials.

Fire Fighting: If a significant quantity of this product is involved in a fire, call the fire brigade.

Flash point: Does not burn.

Upper Flammability Limit: Does not burn.

Lower Flammability Limit: Does not burn.

Auto ignition temperature: Not relevant - does not burn.

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this SDS and the label, instructions on the label prevail. Keep from extreme heat and open flames, and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10.
